Tax Exemption Guidelines under Subsection 44(6), Income Tax Act 1967 effective June 2016

YES, I would like to make contributions to the patients under NKF

- a) A Tax Exemption Receipt shall only be issued to the person/company who makes the payment (name appearing on the cheque or credit card) for the donation. The Tax Exemption Receipt cannot be issued in another person's or company's name.
- b) Donations made via a single cheque or credit card will only receive one (1) tax exemption receipt. In this case, NKF cannot issue several Tax Exemption Receipts in different names under that single cheque or credit card.
- c) The date appearing in the Tax Exemption Receipt cannot be earlier than the bank in date (The Tax Exemption Receipt should only be issued after the cheque had been banked in and cleared).
- d) The Registration Number (for Companies, Foundations and Societies) or NRIC No. for an individual donor is to be included in the Tax Exemption Receipt.
